Present Water Rates: First 3,000 Gallons -- \$19.44 (Minimum)
3,100 Gal – 8,000 Gal --\$ 3.19/1,000 Gallons
8,100 Gal and over-\$ 3.32/1,000 Gallons

(A 4% utility tax will be added to all water sales; therefore, our minimum bill is \$20.22)

Present Connection Fee -- \$600.00 for New Service (3/4 x 5/8 Meter)
Present Service Charge --\$ 10.00 To Establish New Account
Present Security Deposit \$ 75.00 for Residential Owner
\$100.00 for Business and Rental Property

TOTAL FOR RESIDENCE \$685.00
BUSINESS AND RENTAL \$710.00

NOTE: BOTH CONNECTION FEES AND MINIMUM BILLS ARE HIGHER FOR LARGER METERS.

Other charges include:

- \$ 2.00 fire hydrant maintenance fee for all residents served by a fire district.
- \$ 1.00 maintenance fee for all residents not served by a fire district.
- \$ 4.00 public safety fee for all residents in Theodore Dawes VFD.
- \$ 19.00 public safety fee for all businesses in Theodore Dawes VFD.
- 10% of bill or \$5.00 (whichever is greater) Late charge for all bills not paid after the 15th of month.
- \$ 10.00 Fee for Notice of Delinquent accounts.
- \$ 55.00 Fee for Reconnection after disconnection for non-payment.
- \$ 25.00 Fee for turning water on & off for the convenience of the customer.
- \$ 30.00 Fee for customer checks not honored by bank(NSF). All fee must be paid by cash/money order.
- \$200.00 Fee for direct hook-ups without a meter.
- \$200.00 Fee for cut lock, zip tie and or curb stop.
- \$100.00 Fee for tampering with our meter.
- \$200.00 Fee for sprinkler meter.

Disconnects on accounts are done after the 15th day of the month on any past due account. If account is disconnected due to non-payment all fees must be paid before service is reconnected. This includes all reconnection fees or late charges.

In regard to the adjustment of bills because of a customer leak, the Authority will allow the customer credit only for a bill that is \$25 over a normal average water bill. This adjustment is only allowed once in any twelve (12) month period and a receipt for plumbing repairs must be submitted to the Authority.
